

## Grounds Agreement

This agreement between the Michigan State Association (MSA) of the Family campers & RVers (FCRV) and the \_\_\_\_\_, is for the purpose of the MSA holding a state wide campout on the \_\_\_\_\_ between \_\_\_\_\_ 20XX and \_\_\_\_\_ 20XX.

It is agreed that the \_\_\_\_\_ will:

1. Provide exclusive use of the grounds from 12:00 noon Friday \_\_\_\_\_, 20XX through Sunday \_\_\_\_\_, 20XX, except (for persons owning or caring for horses boarded on the grounds. These people will be admitted to care for their horses as usual.
2. Provide space for estimated \_\_\_\_\_ camper units from Friday \_\_\_\_\_, 20XX through Sunday \_\_\_\_\_, 20XX for a fee of \$\_\_\_\_ per night per unit (\$\_\_\_\_ per unit for the weekend). Electric is to be provided to these units with water available on the grounds.
3. Provide for no more than \_\_\_\_\_ host camper units from \_\_\_\_\_ through \_\_\_\_\_. (The weekend prior to the campout or the Sunday through Tuesday before the campout) at no cost for the purposes of preparing for the campout. Same are to be provided with electricity.
4. Provide the existing restroom facilities, lighting presently on the grounds and the following buildings in the camping fees if possible:
  - A building for commercial/door prizes/hospitality (Note: if there is a building charge, list with each building).
  - A building for the youth
  - A building for the teens
  - Grandstands or a place for the program
  - A suitable place for Chapter Projects to be held
5. To allow any desiring camper too enter the grounds after 12:00 Noon on Wednesday \_\_\_\_\_, 20\_\_ for the purpose of holding activities for the early arrivals. They will pay \$\_\_\_\_ for each additional night. The hosts will be responsible for the collection of the additional monies.
6. To provide access to the grounds and buildings on agreed date as in #3, for the purposes of preparing for the campout.

It is agreed that MSA will:

1. Be jointly and individually responsible for the payment of all the agreed upon fees charged for the use of the facilities and for damages occurring to such buildings.
2. Keep the area and buildings being used clean.
3. Comply with existing health regulations.
4. Provide, upon request, a certificate of liability insurance covering the campout.

The fairgrounds will provide:

1. Temporary campground license
2. Trash Removal
3. Temporary restroom facilities if needed/ to be negotiated
